

WAIVER, INDEMNIFICATION AND RELEASE **RELATING TO CORONAVIRUS / COVID-19**

The novel corona virus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is reported to be very contagious. The virus is believed to be spread from person to person contact and/or by contact with contaminated surfaces and objects, and even possibly in the air. People reportedly can be infected and show no symptoms and therefore spread the disease. The exact methods of spread and contraction are not entirely known, and there is no known treatment, cure or vaccine for COVID-19. Evidence has shown that COVID-19 can cause serious and potentially life-threatening illness and even death.

I acknowledge and agree that the Model A Ford Club of America / Model A Touring Club cannot prevent me (or my children) from being exposed to, contracting, or spreading COVID-19 while attending any function or on any property while on tour. I understand that it is not possible for the Model A Ford Club of America / Model A Touring Club to be able to prevent against the presence or spread of the disease. Therefore, If I choose to attend this tour/function, I may be exposing myself or my child(ren) to and/or increasing my/our risk of contracting or spreading COVID-19.

Assumption of Risk. I have read and understood the above warning concerning COVID-19. I hereby choose to accept and assume the risk of contracting COVID-19 for myself and/or my children in order to attend the Model A Ford Club of America / Model A Touring Club tour/function. Attending is of value to me and I accept the risk of being exposed to, contracting, and/or spreading COVID-19 in order to attend. I am also aware that there are reports of human to animal or animal to human transmission of COVID-19, and the undersigned or the undersigned's animal(s) may be exposed to and contract this disease.

Waiver of Lawsuit/Liability: I hereby forever release and waive my right to file a claim, seek damages or compensation, or bring suit against the Model A Ford Club of America / Model A Touring Club and its board members, officers, directors, managers, officials, trustees, agents, employees, or other representatives ("Releasees") in connection with exposure, contracting, infection, and/or spread of COVID-19 related to attending any event/function/tour by the Model A Ford Club of America / Model A Touring Club. I understand that this waiver means that I irrevocably, on behalf of myself, my children and my next of kin or estate, give up the right to bring any claims of any kind or nature related to COVID-19 including claims of personal injuries, death, disease or property losses including but not limited to claims of negligence and forever give up any claim I may have now or in the future to seek damages, whether known or unknown, foreseen or unforeseen related to contracting COVID-19 during the tour, event, function or on any property related to the Model A Ford Club of America / Model A Touring Club . I further agree to defend, indemnify and hold Releasees free and harmless from and against any such claims.

I also affirm and agree to the following:

*Neither I, nor anyone in my immediate family are currently suffering from a fever, dry cough, fatigue, difficulty in breathing or any other known COVID-19 symptoms. I agree to notify the MAFCA / MATC immediately if I or my family members being to experience such symptoms so that the MAFCA / MATC can notify the local public health department.

*Neither I, nor any of my household members have been diagnosed with COVID-19 within the past 30 days.

*Neither I or any of my family members have traveled outside of the country or to any city considered to be a "hot spot" for COVID-19 infections within the past 30 days.

Choice of Law: I understand and agree that the law in the state of California will apply to this agreement, and that venue shall rest exclusively with the Superior Court of the State of California for the County of San Luis Obispo.

I HAVE CAREFULLY READ AND FULLY UNDERSTAND ALL PROVISIONS OF THIS WAIVER AND RELEASE, AND FREELY AND KNOWINGLY ASSUME THE RISK AND WAIVE MY RIGHTS CONCERNING LIABILITY AS DESCRIBED ABOVE:

I UNDERSTAND THAT THIS DOCUMENT IS A PROMISE NOT TO SUE, A RELEASE OF ALL CLAIMS AND INDEMNIFICATION, AND BY SIGNING THIS DOCUMENT I GIVE UP CERTAIN LEGAL RIGHTS I MAY OTHERWISE HAVE.
